HEI shall ensure delivery of Self Learning Material to learner within a fortnight from the date of admission (for ODL programmes) and HEI shall ensure its uploading on the learning platform before the start of academic session (for Online Programmes) as per Annexure-VII of University Grants Commission Online Programmes) Regulations, 2020, (including its amendments from time to time). Information about the same shall be intimated to UGC in a timely manner.

17. That the Higher Educational Institution shall ensure to offer programmes through Learner Support Centers within the territorial jurisdiction, as defined in the regulations (**Applicable for only Central and State Universities**).

18. That the Higher Educational Institution shall ensure to offer programmes from its Head Quarters only and duly recognized/approved off-campus centers (**Applicable for only Private and Deemed to be Universities**).

19. That the Higher Educational Institution shall ensure that examination of the programmes in Open and Distance learning mode and/or Online mode shall be managed by the examination or evaluation Unit of the Higher Educational Institution and shall be conducted in the


